### September 21, 2006 (Thursday)

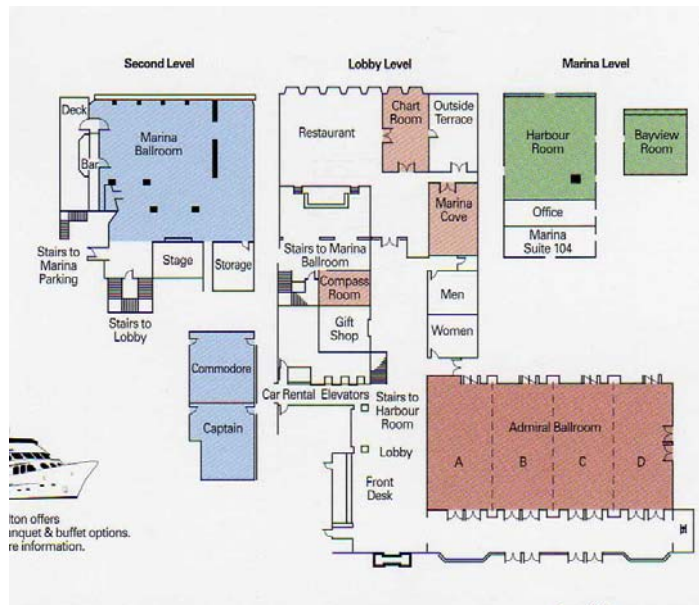
am: General session w/discussions and presentations of test results
